Per the process outlined in OMB memorandum M-18-8, the Louisiana State University Health Sciences Center requests that the micro-purchase threshold be raised to $\$ 25,000$ to be consistent with Louisiana State law. Scientific research is one of the primary missions of the Health Sciences center, and in recognition of that, the Governor's Executive Order defining Small Purchase Procedures (currently JBE 2018-18) outlines the following exemption in Section 5(A)(25):

Section 5: The following items are considered small purchases and may be procured in the following manner:
A. No competitive process is required for the following items:
25. Scientific and laboratory supplies and equipment when procured by colleges and university for laboratory or scientific research not to exceed twenty-five thousand dollars $(\$ 25,000)$ per transaction

This exemption has proven to be critical in ensuring continuity and consistency of scientific research results and avoiding the introduction of unnecessary variability into the process. We respectfully request that the micro-purchase threshold be raised to $\$ 25,000$ to match this exemption and be consistent with State law.
