New Board of Regents spending policy: for professorships and Chairs, Regents dictate carry over 25% of current market value of professorship into next year. \$23.5M invested by BOR, and if building up it is not being spent for the intended impact.

 - 1. Moneys to renovate labs at MEB? large project size. Discussed with Steve. Needed 'now.' Unable to update 'now.'
 - 2. Is animal space needed on floors 5-7... likely not once Trail bldg. ready. Likely no future animal space in MEB.
 - vii. Special Legislative Session \$300M budget gap. Governor's stance and plan seems pro-HSC. Challenging plan would have significant effect on HSC campus.
 - viii. Shuttle Progress kudos to Senator Spieler. Signage in place in employee areas in hospital. Follow-up metrics to follow.
 - ix. Senatorial vacancies: Dr. Kirk Nelson from Allied Health has left LSU. Dr. Krystal Vaughn was to have attended in his absence. Bylaws state school in question

can name a replacement, however regular elections to be held by July of same year. George Hebert to notify faculty assembly from Allied Health.

 - a. Pedagogy and outcomes
 - b. Teaching Academy would supply individuals on Core Curriculum Committee. These would be recognized quality educators who would hierarchically identify pros and cons of curriculum from an outside perspective on a lecturer's ability to deliver content.

 - 5. Will also aid in securing / supporting grant writing.
