- 6. Report from Board of Supervisors Meeting
 - a. UMC hosted last meeting
 - i. Convened following tour of UMC rave reviews
 - ii. Presentation by new CEO Bill Masterton
 - 1. Was head of hospital similar to UMC in another state, covered 6 zip codes, UMC covers 54 zip codes
 - 2. 21% decline in uninsured patient population
 - 3. Currently 9 state employees on site to register pts for Medicaid
 - 4. 5 specialized svc lines neuro, cancer, heart, behavioral, one more
 - a. All led by LSU faculty, no positions led by Tulane faculty as yet

- iii. Question from BOS why are all beds not full?
 - a. Specialty services rely on outpatient care and primary care physicians for referral
 - b. Chancellor Hollier was questioned re: 3 yr med school program proposed in Lafayette, no funds allocated in LFT for said program as yet
 - ULL in negotiations to teach basic science info, however may only be able to negotiate with ULL Nursing faculty to teach med school basic sciences
 - 2. Dr. Ghali appointed Chancellor of LSU HSC in Shreveport
 - a. Dr. Hollier working out details with private partnerships
 - b. Residents taking care of pts in health science hospital, and faculty billing out through themselves.
 - Presentation on 'new era of cooperation' between HSC NOLA/Shreveport

 - 1. LSU legacy
 - 2. Tiger nation outgrowth of Texas Tiger program
 - a. LSU alumni living in Texas who want children going to LSU
 - 3. LSU Tiger Legacy Program
 - a. Students who leave state and attend schools out of state will pay extra for tuition due to receiving scholarship
 - b. Extended to children of faculty and staff, although not at HSC
 - c. FS resolution to extend Legacy program to HSC faculty and staff
 - i. Motion Senator Cefalu
 - ii. Second Senator Guillory

 - a. Ongoing search for chief technology officer
 - i. Should serve all of LSU schools, yet no other school was represented on search committee
 - ii. He was asked to interview a candidate, yet he did not know the position was open
 - 2. WorkDay
 - a. Time and effort reporting system
 - b. Difficulty in logging hours/clocking in/out
 - Cope asked BOS to slow down on decision for Mike VII to decide on live mascot
 - a. Only 25 other campuses have domestic animals
 - b. 8 have 'wild' animals
 - 4. Trouble with Visas on BR UG campus
 - a. Can grant J1 visas, however ill equipped to handle bureaucratic issue
