Welcome

- Introduction: new senator for School of Dentistry Dr. Waleed Zaid
- Guest speaker: Human Resources Rosalynn Martin, Director of Human Resource Management. Dr. Martin discussed her goal to improve the value of Human Resources. She will design and implement new programs, improve current services, reestablish goals, and set a positive tone for her staff of 22 employees. She believes in trust, teamwork, and innovation, and hopes to improve intra- and interdepartmental relationships. She discussed several goals and projects:
 - One of her main goals is to automate forms, such as the PER form. She would like to have automation in place for "the entire employee life-cycle." They are currently reviewing a variety of software systems for this project.
 - Another goal is to improve employee engagement by revamping orientations and creating an employee recognition program. She would like to have a committee of faculty and staff to help plan such events.
 - o Proposal for unclassified learning and development plan for next fiscal year
 - Started HRM Liaisons group which meets monthly (includes Business Managers)
 - Completed the campus wide market study for unclassified employees in May 2017
 - Would like to partner with Faculty Senate to work on the market study for faculty
 - Working on an online performance development plan for unclassified employees (includes administration)

- Recycling update: Per John Ball, new recycle bins ("with clearer instructions") will be
 purchased in the next several months for the 3rd floor areas of the SON/MEB including
 the atrium. Test the new bins before expanding use further in the MEB. New bins will
 also be placed in SON per Dr. Porche.
- Resolution: HR working on plan to implement evaluations of administration; Chancellor has never responded to resolution 17-01 sent on June 14, 2017. President Spieler will resend.
- Crime alerts: Dr. Moerschbaecher says that the Clery Act limits/dictates how the alerts work to some extent; have committee send him recommendations and he will share with Edwin Murray
- AHA Heart Walk was last Saturday, November 11th according to web the walk raised \$342,718.00.

New Business

- Shuttle President Spieler spoke with John Harman about getting a sign for our stop;

- No report from Board of Supervisors Meeting, Friday, October 13th
- Reports from Assemblies
 - Allied Health: Faculty Assembly discussed December paycheck issue for monthly employees. Due to the holiday, December paychecks are not issued until January. This causes financial problems for many employees. Senator Hebert reminded the senate that in order to change this system, payroll would have to issue a 13th payment in the

- first year, and that would be problematic on many levels. As such, the likelihood of payroll changing that payment cycle is slim.
- Dentistry: Recently held a Professionalism Ceremony
- Graduate Studies: Research Day was November 3rd. Participation was excellent including 87 presentations and many volunteers. Senator Mandal was recognized for her service and awarded the Jack Hines Award. [According to the Graduate Studies web site, the Jack Hines Award is given to a faculty or staff member who has demonstrated outstanding commitment to the School of Graduate Studies in honor of the beloved Jack D. Hines, III, former Director of the School of Graduate Studies.] Everyone is encouraged to attend, participate, or volunteer in this educational event.
- Medicine: Faculty Assembly discussed the LCME site visit. The Assembly will also look at
 its bylaws regarding Faculty Senate eligibility. Currently only those faculty listed as fulltime in the PeopleSoft system are eligible. Senator Farrar mentioned that Dentistry
 updated their eligibility several years ago so that all faculty are eligible.
- Nursing: December 14th is graduation. An online RN-BSN program will be offered beginning in fall of 2018.
- Public Health: Ken Boe visited their October Assembly meeting. Library: 2 director candidate interviews: Friday, November 17th and Monday, November 20th; Insurance claim for theft was denied; no further information on the issue; New off-campus access system as of tomorrow, November 15th. Seamless for existing users. Barcode and PIN required for login. Instructions will be available on the library web page; National Library of Medicine Traveling Exhibit poster display in Library Commons plus supplemental library display in library: "Every Necessary Care and Attention: George Washington and Medicine" on the health and safety of Washington's family, staff, slaves, and troops. Will be here November 13 – Dec 1 and the Dental Library Dec 4 – Dec 21; remind your teaching faculty to communicate with our librarian liaisons regarding books needed for their courses.
