- I. Approval of June Minutes: Unanimously accepted
- II. President's Report First Report
  - 1. Goals for the upcoming year:
    - i. Continue the momentum of the Faculty Senate developed in recent years, including enhanced involvement in campus-wide activities and decision-making that affects faculty interests.
    - ii. Deal effectively with budgetary issues, both pre-existing and new as a result of loss of stimulus funding (potential \$23M additional loss in the 2011-12 fiscal year).
    - iii. Improve the dissemination of information to our faculty body, specifically regarding budget planning, updates on planning for the new medical center, changes to retirement/benefits plans, and concerns regarding other Center-wide issues such as information technology.
  - 2. Meeting with Dr Moerschbaecher:

- i. Budget: Scope of cuts still remains to be determined, but planning for next fiscal year is designed to address worst case scenario if it becomes necessary.
- ii. Academic Medical Center pressure exists to downsize the facility from 400 to 250 patient beds, which would effectively eliminate the anticipated good payor mix.
- iii. Noted improvements in campus safety thanks to HSC committee activities over the past year.
- iv. Update on FEMA funding for dentistry facility r&r: no specific new news except that expectation is for it to be finalized ~'any day now.'
- III. Council of Faculty Advisors (COFA) and Board of Supervisors (BOS) July 2010 meeting update (Dennis Paul):
  - 1. General COFA Information: Each school sends a representative to the COFA to meet prior to the Board of Supervisors' monthly meeting. Council members may address the board directly.
  - 2. Each Chancellor reviewed proposed cutbacks for the anticipated upcoming budget deficit
  - 3. LSUHSC NO is preparing for a \$23M cut, which could prompt entire program closures.
  - 4. LSUHSC Shreveport have proposed an eleven day furlough for all employees.
  - 5. The chancellors of the various campuses collectively reported that additional upcoming cuts are destroying higher education in the state of Louisiana.
  - 6. The possibility of declaring financial exigency was raised (see Section 9.4 LSUHSC Faculty Handbook, <a href="http://lsuhsc.edu/no/administration/academic/FacultyHandbook.pdf">http://lsuhsc.edu/no/administration/academic/FacultyHandbook.pdf</a>) OR (see Section 5-13 Bylaws and Regulations LSU System, <a href="http://www.lsuhsc.edu/no/Administration/bylaws/">http://www.lsuhsc.edu/no/Administration/bylaws/</a>). Some faculty members at various schools have received potential termination letters.
  - 7. Collective Bargaining LSU Baton Rouge Faculty Senate President, Kevin Cope announced that their body has chosen the Louisiana Association of Educators to solicit support for main campus faculty.
  - 8. La Grad Act Passage announced Allows for 5% tuition increase for this year and 10% increase next year if certain conditions met. Both health science centers currently exceed set conditions for graduation and retention.
  - 9. New Academic Medical Center Oversight Committee introduced.

## IV. Old Business

- ORP HB 229 passed both La House and Senate and is now up for vote this fall for as
  an amendment to the state constitution. It would require any changes to the public
  retirement system which had an actuarial cost to be approved by 2/3 majority of the
  legislature as opposed to simple majority as currently stipulated. This would potentially
  make it much more difficult to pull ORP out of TRSL or initiate other substantive
  reforms.
- 2. Budget update Dennis Paul reiterated that the proposed additional reductions are in preparation for the worst case scenario and that our chancellor's strategy will be to employ targeted cuts, as opposed to across the board reductions.
- 3. Allied Health Holiday Schedule Clarification tabled.

4. SOM Faculty Forward Survey – Stephen Brierre reported that Janis Letourneau could be asked to present a short summary of the results to the Faculty Senate. The Faculty Senate declined after a short discussion.

- 3. Website Advisory Committee (WAC) Dennis Paul made the point that the WAC which was to be created in response to a Senate resolution in March 2009 has never met. He made a motion the issue be raised again with the Chancellor. J Sturtevant added that the SOM was advised to stop its efforts to address the website issue as it reflects a campus-wide issue. The senate body agreed that the Executive Committee would meet with the Chancellor to raise the issue again.
- 4. Collective Bargaining effort at LSU main campus Dennis Paul reported that the main campus is moving forward with its efforts to create a collective bargaining agreement and that the main campus has asked other campuses to investigate the feasibility of doing likewise in their respective locations. The senate body agreed that the Professional Rights, Responsibilities, and Faculty Welfare committee should investigate the issue and report back to the senate.
