II. President’s Report

1. Meeting with Vice Chancellor Moerschbaecher

i. Clery Act –

1. Senate Executive Committee alerted Vice Chancellor Moerschbaecher regarding our non-compliance and potential consequences.

2. Vice Chancellor Moerschbaecher asked the Office of Compliance to address the issue

3. Information submitted to the US Dept of Education for years 2008, 2009, and 2010 incorrectly indicated that the campus was free of crime

4. Vice Chancellor Moerschbaecher noted he would discuss the issue with Kathy Muslow to gain the correct information

2. IT Committee meeting with Bettina Owens and Ken Boe (see committees report)

3. Proposal to invite Chris Vidrine to upcoming FS meeting to offer budget update accepted

4. Proposal to invite Sandra Andrieu to upcoming FS meeting to offer IPE update accepted

5. Budget update –
  - i. Direct appropriations from the state to higher education are expected to be lowered by the amount that tuition and fee raises will increase revenue coming into the system.
  - ii. Expressed the opinion that a proposed 3% increase in the employee contribution to the retirement package which can be used for non-retirement purposes amounts to a tax on public employees

### III. Council of Faculty Advisors (COFA) and Board of Supervisors (BOS)

#### 1. COFA

- i. Announced the newest BOS member, Jack Laughton, Jr. from Lake Charles; the entire BOS is now comprised of members selected by Gov. Jindal
- ii. Announced an “open” meeting of all LSU Boards at the Pennington Conference Center on Feb 27<sup>th</sup>, 2012
- iii. Anticipating upcoming state retirement legislation for debate
- iv. Report from the Nation Center for Higher Education Management Systems (NCHEMS) proposes that both HSC’s be under LSU A&M Chancellor
  1. No faculty input to date
  2. President Lombardi proposal for a 3 year study of the NCHEMS report
- v. LSUHSC-S raised an issue concerning salary inequities when comparing similar positions in the various campuses
  1. CFA will conduct a salary analysis for comparison and present findings to President Lombardi

#### 2. BOS

- i. Fred Cerise, LSU Vice President for Health Affairs and Medical Education, reported that new budget cuts will bring along necessary cuts to vital services (see following article links) with a detrimental effect on healthcare and education.
