Dr. Gunaldo presented many things concerning the SACSCOC QEP Goals (Quality Enhancement plan)

I have included her power point in the minutes and the goals are listed. She stated that the team is constantly assessing and changing issues to make the IPE experience /education more efficient. By doing this the number of faculty used to help has been reduced .This program began using two campuses but now has centralized to one campus.

Feedback received when this program first began stated that students from different schools were afraid to talk to one another. They came to the program with preconceived ideas and biases. The students now realize that Team Up is actually helping with breaking down barriers between professions. One second year student stated that it "required 2 years of interaction and then the walls slowing started to erode".

Dr. Gunaldo stated that if LSUHSC had an Office of Professional Development the work that has been done may have been done in a more streamlined fashion. The question was asked what Faculty Senate could do to help initiate an Office of Professional Development. Senator Farrar stated that the Senate has tried in the past but was told by administration that forming this could

not happen at the moment. Dr. Gunaldo stated that perhaps we will have to wait for a new QEP which would require this.

Dr. Gunaldo also talked about accreditation standards and responses. She will email Department Heads and Program Directors and let them know that CIECP can support writing the responses concerning IPE. The schools could share content which would increase efficiency. She will also be sending a Faculty Survey about 3-4 questions focusing on faculty teaching multidisciplinary courses including clinical faculty



President Report:

- There was no Executive Committee meeting with Dr. Moerschbaecher.
- The Coat Drive was very successful. A total of 125 coats were collected and were donated to Barron's Bears and Hero 1 in Jefferson Parish. President Crabtree will talk with Tanya DeSilva and will inquire if this this should be an annual event.
